- Renewal Process: Mr. Abdi submitted the renewal process to the Guild and is waiting for feedback and response from the Skyline before March.
- <u>Sip:</u> Skyline Director was working in the last few weeks to put together a school
  improvement plan for Skyline school district in response to the letter that was sent to
  the Guild. The SIP was sent to the Guild. And the Guild confirmed that it received the SIP
  and will review and respond back.
- **Board Elections:** According to the proposed SIP that is approved by the board, Skyline board wants to hold board elections. The Skyline director is also emphasizing this action in order to meet authorizer expectations.
- Academics: Skyline students are preparing for the MCA in April. Teachers are preparing students for all strategies and tactics for students to be successful in their upcoming MCA.
- <u>Audit:</u> Audit was submitted on time and the board approved for the process and the results of the audit.
- **Staffing:** Staffing is still a problem for Skyline. All hands are on deck for Skyline staff this year. And everyone is wearing more hats to fulfill different positions.
- <u>Drivers:</u> Still, schools are struggling to find consistent drivers due to driver shortages.
   Skyline is talking to all families to make sure they understand the situation and the fact that driver shortages are a problem for all schools.
- <u>Lease & Space:</u> Skyline director, Mr. Abdi is engaging with St. Stephen's church landlord and Skyline current landlord to make sure lease and student enrollments are aligned for 2023-2023 school year to make sure the budget is balanced. Skyline has been paying more than the enrollment
